- 1. Approval of the Agenda for the February 12, 2024 Meeting Approved and seconded as written
- 2. Approval of the Minutes of the November 28, 2023 Meeting Approved and seconded as written
- 3. Office of Research Updates
  - a. URC Policy Updates
    - The Board of Trustees approved the revised policy
    - The new bylaws are ready to be posted to the Office of Research website
    - Dr. Bond will send memos to the deans from each of the six colleges, requesting two representatives from each college
    - There will also be a university-wide election for three at-large member positions
    - At-large members will be self-nominated or nominated by their colleagues and will be elected through voting procedure by eligible faculty and staff members
    - Current URC members are eligible for re-election
    - Nominations for members for 2024-2025 should be forwarded to Joy Yard before April 15
    - The new URC will consist of 16 full members, which includes a representative from the Graduate Council, plus corresponding members
    - The new URC will be in place at the start of the fall semester

      - ▶ Wednesday, March 20, 12:00 2:00 pm: URC meeting to review FSI proposals
